Contributions of less than \$300 must be paid in full on June 1st, 2021. Contributions of \$300 or more may be paid in two instalments, due on June 1st, 2021 and September 1st, 2021. For payment methods and other useful information, see the back of your account.

Société de développement commercial

The Sociétés de développement commercial (SDC) are non-profit organizations that contribute to the economic development and enhancement of commercial thoroughfares in given areas. These organizations include businesses, service providers and professional offices in these areas.

Every SDC determines its parameters for the calculation of contributions and adopts its operating budget at its annual general assembly.

Montréal offers support to SDCs, notably by issuing the accounts and by collecting payments.

In 2021, there are 23 SDCs in Montréal.

Annual contribution

SDC accounts are sent to member businesses occupying the premises on the first day of the fiscal year, which is January 1st. Should the occupant cease their activities during the course of the year, their contribution will not be reimbursed.

In conjunction with the Association des sociétés de développement commercial de Montréal, the city has postponed the deadlines for SDC contributions for 2021, due to the current pandemic context. The new due dates are June 1st and September 1st, 2021.

Basis of calculation

The basis of calculation is determined by every SDC, based on one or several of the following elements:

- The surface area occupied
- The non-residential property value of the premises
- The location
- A fixed amount

Factors that may impact your 2021 contribution

Several factors may influence the amount of your contribution to be higher or lower than the previous year.

Every SDC adopts an annual operating budget. The variation of this budget from year to year directly impacts the calculation of member contributions. SDCs select parameters that define the basis for their calculation. These parameters may therefore change, thus impacting the amount as a result.

Moreover, if your SDC opts for a calculation based on the non-residential property value, the variation on the assessment roll for 2020-2022 may affect the calculation of your contribution amount.
