** The certificate from the professional guide and assistance dog training organization is required.

*** Permits free the first year if requested within fifteen days following adoption (with supporting documentation).

Documents required:

- ☐ The completed form.
- ☐ Scheduled 1 completed if the license application pertains to one or more cats, or Schedule 2 if the license application pertains to one or more dogs. Schedule 1 and Schedule 2 must be filled out according to the number of pets (e.g., 2 dogs = One Schedule 2 filled out for dog #1 and one Schedule 2 filled out for dog #2). Every question must be answered in order for the application to be processed.
- ☐ A photocopy of a valid photo ID and proof of address. See the list of accepted documents at montreal.ca.
- ☐ A cheque made out to **Ville de Montréal**. The amount to be indicated is the total of boxes selected on the previous page (1). If the application is made after the permit has expired, an additional fee of \$10.25 per permit applies and must be added to the total payment amount.
- ☐ Proof of sterilization for each animal.
- ☐ Proof of microchipping for each animal.

Documents required, if applicable:

- ☐ A written notice from a veterinarian stating that sterilization is not medically appropriate for the pet.
- ☐ A written notice from a veterinarian stating that microchipping is not medically appropriate for the pet.
- ☐ Proof of breed registration for a breeding dog or cat. See the list of breed associations at montreal.ca.
- ☐ A certificate from a professional guide or assistance dog training organization. See details at montreal.ca.
- ☐ Proof of adoption from a shelter within the 15 days preceding the permit request, or a certificate from the shelter confirming custody for temporary foster care of the animal.

Mandatory disclosure

Montréal will not issue or renew a pet license if the applicant cannot make the following solemn declaration. This also applies if the applicant is a legal entity and cannot confirm to the city's designated authorities that the people who will exercise the rights related to the pet license would have met the same conditions if they had applied for the pet license themselves. Montréal refuses to issue or renew a pet license if it is aware of a declaration of guilt. Anyone who provides false, inaccurate or incomplete information is committing an infraction by doing so.
