It is dead or in a state of irreversible decay.  It is in an irreversible state caused by a disease, a structural deficiency affecting its solidity or serious damage that it causes to property (does not constitute a nuisance or a damage the normal inconveniences related to the presence of a tree, in particular the fall of twigs, leaves, flowers or fruits, the presence of roots on the soil's surface, the presence of insects or animals, shade, unpleasant odors, exudate of sap or honeydew or the release of pollen.  Report of an expert (arborist, forest engineer/technician, horticulturist, agronomist, landscape architect).  It is located within or less than 3 meters from a planned construction site, except in the case of a sign, ancillary structure or projected retaining wall.  It is located in the projected site of a swimming pool or of a parking lot, or, in the front yard, of an access to a building only if no other space is available elsewhere on the lot.  It represents a risk of spreading a disease or is an invasive exotic specie, in which case it must be replaced.  In order to create an 5 meter wide opening to the shore to give access to a shoreline when the slope of the shore is less than 30%.  In the case of a rearrangement of the yard (the felled tree must be replaced by at least two trees, within three months).  Comments
